3. Hazard Identification:

EMERGENCY OVERVIEW: Harmful by inhalation (irritant) and if swallowed (irritant). Irritating to eyes. Harmful to aquatic organisms, may cause long-term adverse effects in the aquatic environment.

4. First Aid Measures

EYES: Flush eyes with water for 15 minutes. Cold water must be used. Get medical attention if irritation persists.
